THE PEOPLE'S TRIBUNAL



The People's Tribunal on Crimes Against Humanity is a public investigation of three interrelated threats to human existence: 1) a 100-year eugenics agenda, 2) the bioweapon origin of COVID-19, and 3) AI and the totalitarian digital control system. While few are fully aware of the extent of these dangers, the evidence to be presented at the Tribunal is overwhelming (it is summarised at www.waronus.org).

As the government won't investigate itself, and the judiciaries are corrupted, the Tribunal is appealing to a higher authority: the Court of Public Opinion.

The proceedings are partly inspired by the 1967 Russell-Sartre Tribunal on the Vietnam War and partly by the Nuremberg Trials:

- The Prosecutor presents the evidence
- The Defense represents the accused
- The Jury is the Public - reaching a verdict by the first-ever global online vote

This public examination of the depopulation and digital enslavement agenda will pave the way for reclaiming human sovereignty and survival.

WHY IT WORKS

Elite-controlled media keeps humanity in the dark. Independent media voices haven't awakened enough of the public.

The Tribunal is the breakthrough.

A 16-week trial, with over a hundred witnesses and earth-shattering evidence will create a critical mass - too big to ignore.

This live-streamed event, with the architects of genocide facing exposure, will command universal attention and interest.

The evidence presented will inspire the public to retake political control and defend civilization.

A media event to awaken the world.





UNIFYING LEFT & RIGHT

To stop the eugenics agenda, the public must stand together.

The Tribunal is an opportunity for such unity.

- The left will strongly resist eugenicist racism.
- The right will strongly resist attacks on human freedom.
- Both will resist the threat to human life.

The depopulation agenda (and the coming digital tyranny) will unite the left and the right in this fight for human survival.

EVIDENCE

1) Depopulation Agenda

A 100-year American eugenics agenda: US elite support of the Nazi Holocaust; weaponizing cancer & viruses (AIDS); sterilizing millions; depopulation made official US policy via NSSM-200. Evidence at www.waronus.org

2) Weaponization of SARS CoV-2

2013 patent on Furin Cleavage Site; insertion of HIV into SARS-2; blood clots; myocarditis; infertility; immune-system degradation; cancer; 7 million deaths.

3) Digital Enslavement and Silent Weaponry

AI, Biometric IDs, surveillance, social credit scores, CBDCs, drones, robots, infertility chemicals, food shortages, EMFs, etc.

All evidence pre-vetted and publicly accessible.

The means, motive and opportunity for genocidal crimes against humanity.

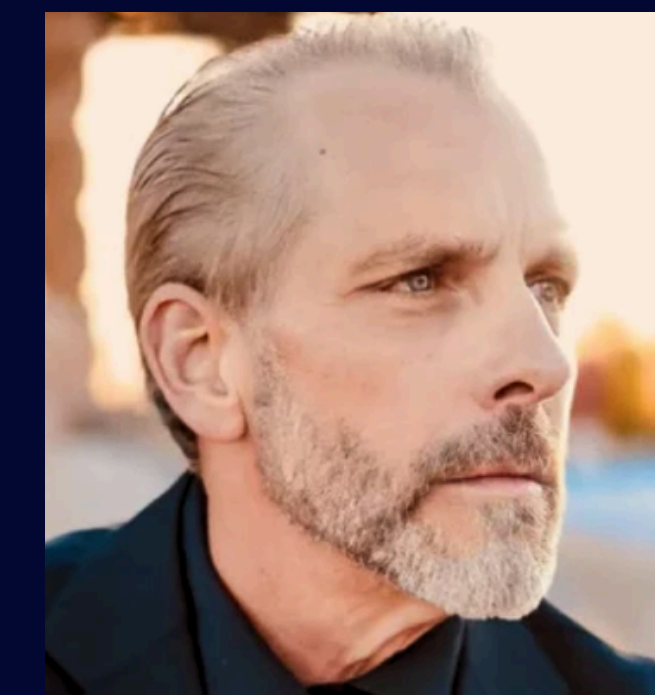

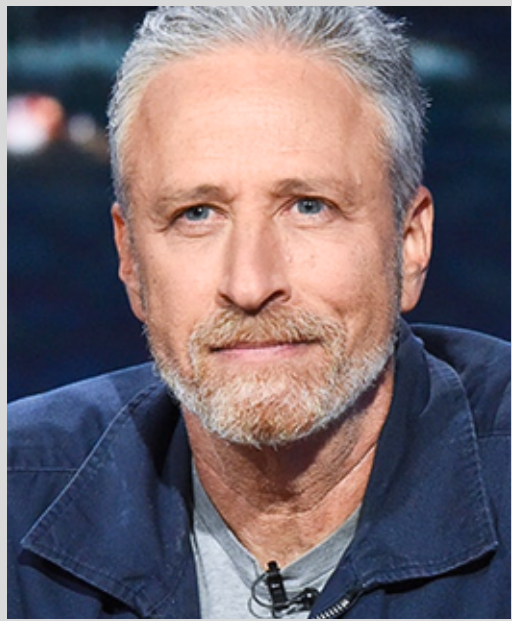

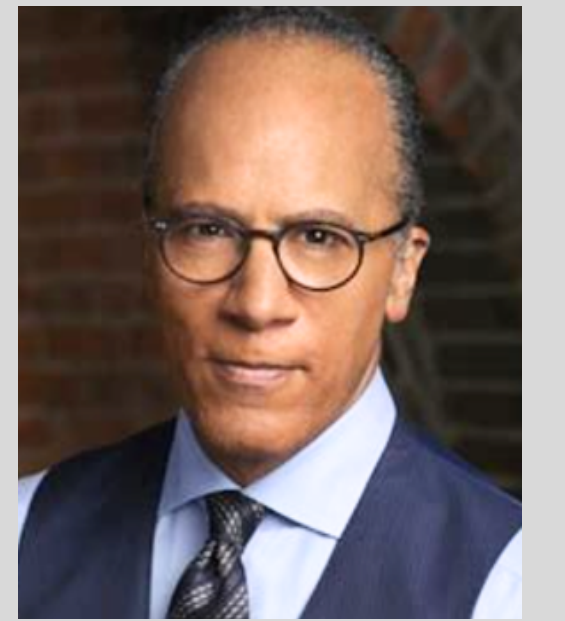

POST-VERDICT

In the case of a guilty verdict, the Tribunal will recommend steps for unwinding eugenicist control of government, the UN, the tech industry, finance and the media. Examples include:

THE TRUTH PARTY - Create an independent political party which sets aside partisan issues to focus on rooting out the depopulation crime syndicate. and tightly controlling AI, electronic surveillance, Biometric IDs, CBDCs, bioweapons, robots, drones, EMFs, etc.. Political candidates will take televised polygraphs to verify they have not been bribed, blackmailed or are part of the Agenda.

GLOBAL FORUM ON HUMANITY - Organize a live-streamed conference exploring non-utopian political, economic, technological, environmental, moral and spiritual ways for 8 billion people to co-exist and flourish on this one planet.

STATE RIGHTS - To prevent Federal & corporate tyranny, push State laws rejecting Biometric IDs, CBDCs, online surveillance, AI-control, etc.

CASH / GOLD / BITCOIN - Promote financial freedom by auditing the Fed and promoting Cash, Gold and Bitcoin.

EXIT THE UN - Reclaim national sovereignty by leaving the globalist run UN as discussed at preventgenocide2030.org



DEFENDING HUMANITY

Throughout history, oligarchs have repeatedly exterminated neighboring tribes and even culled their own populations. Why would things be any different today? Have we learned nothing from the fifteen genocides of the last century? The critical difference now is technology. Covert bioweapons combined with the emerging digital control grid will give them unprecedented power to eliminate the majority of humanity while enforcing totalitarian compliance on the rest.

There is reasonable suspicion that this is already underway. The documented roles of the US military and Moderna in the engineering of SARS-CoV-2 — set against a long history of eugenics and population control ideology — provide a clear means, motive, and opportunity for crimes against humanity. Their efforts to conceal their involvement in causing Covid only strengthens the case for an independent investigation. Yet those in power will never investigate themselves. We cannot afford to remain passive. They have already poisoned the entire planet and harmed our children. This is not a drill, and the time to act is rapidly running out.

The People's Tribunal represents our best opportunity to fully expose the depopulation agenda and to rally the global population in self-defense. If the ruling elites and governments are truly innocent, they should welcome the chance to clear their names. We are at a moment comparable to the American Declaration of Independence, when it fell to ordinary citizens to stand up against tyranny. If we wish to survive, we must do so again. The Tribunal offers the platform, the evidence, and the global reach needed to awaken the public and defend civilization.

The choice before us is stark: remain silent and risk everything — or mobilize our fellow citizens to fight for our lives and liberties. What we need now is the courage to resist.
